No. 1 **Minor's permits**

Page 6, Schedule 2. Insert after line 19—

[11A] Section 10, note

Omit the note.

No. 2 **Recreational hunting**

Page 7, Schedule 2. Insert after line 32—

[15A] Section 12 Genuine reasons for having a licence

Omit "*recreational hunting*" from the Table.

[15B] Section 12, Table, Reason: recreational hunting/vermin control

Insert "be a current member of a hunting club approved by the Commissioner in accordance with the regulations and" after "The applicant must".

[15C] Section 12, Table, Reason: recreational hunting/vermin control, paragraph (b1)

Omit "that Act, or". Insert instead "that Act".

[15D] Section 12, Table, Reason: recreational hunting/vermin control, paragraph (c)

Omit the paragraph.

No. 3 **Minor's permits**

Page 8, Schedule 2. Insert after line 10—

[20A] Section 28 General power to issue permits

Omit section 28(b).

No. 4 **Minor's permits**

Page 8, Schedule 2. Insert after line 41—

[23A] Section 32 Minor's firearms permits

Omit the section.

No. 5 **Recreational hunting**

Page 13, Schedule 2, proposed Part 13. Insert after line 27—

47 Recreation hunting licences cancelled

A licence issued for the genuine reason of recreational hunting and in force on the day the *Terrorism and Other Legislation Amendment Act 2025*, Schedule 2[15A] commences is cancelled.

No. 6 **Minor's permits**

Page 13, Schedule 2, proposed Part 13. Insert after line 27—

48 Minor's firearms permits

A minor's firearms permit in force on the day the *Terrorism and Other Legislation Amendment Act 2025*, Schedule 2[23A] commences is cancelled.

No. 7 **Minor's permits**

Page 14, Schedule 3. Insert after line 7—

[3A] Clause 24 Term of permit

Omit "Except in the case of a minor's firearms permit, a". Insert instead "A".

No. 8 **Minor's permits**

Page 14, Schedule 3[4], line 8. Omit "**Term of permit**".

No. 9 **Recreational hunting**

Page 14, Schedule 3. Insert after line 12—

[5A] Clauses 30, 31 and 34, headings

Omit "**Recreational hunting/vermin**" wherever occurring.

Insert instead "**Vermin**".

[5B] Clauses 30–32, 34, 96, 108 and Schedule 1

Omit "recreational hunting/" wherever occurring.

No. 10 **Minor's permits**

Page 14, Schedule 3. Insert before line 13—

[5C] Part 5 Minors' firearms permits—special provisions

Omit the part.

[5D] Clause 93 Approval of shooting range

Omit clause 93(2)(b), (3) and (8).
