Proposed amendments

- No. 1 **Detachable magazines**
Page 4, Schedule 2[3], line 39. Insert “detachable” before “magazine”.
- No. 2 **Biathlon rifles**
Page 4, Schedule 2[3], Insert after line 43—
 - straight pull biathlon rifles with a calibre of .22 inch
- No. 3 **Detachable magazines**
Page 5, Schedule 2[5], line 4. Insert “magazine capacity of no more than” before “5 rounds”.
- No. 4 **Detachable magazines**
Page 5, Schedule 2[5], line 5. Omit all words on the line. Insert instead “detachable 5 round magazine”.
- No. 5 **Biathlon rifles**
Page 5, Schedule 2[6], line 10. Insert “, other than straight pull biathlon rifles with a calibre of .22 inch” after “shotguns”.
- No. 6 **Exemption for professional shooters**
Page 5, Schedule 2[9], proposed section 8A(1). Insert after line 35—
 - (b1) for a licensee who possesses and uses firearms for professional shooting—no limitation,
- No. 7 **Excluded firearms**
Page 6, Schedule 2[9], proposed section 8A. Insert after line 3—
 - (3) The following firearms do not count towards a limitation in this section—
 - (a) single shot centre-fire or single shot rimfire rifles—
 - (i) used for target shooting, or
 - (ii) that are 100 years old or older,
 - (b) air rifles with a calibre of up to .22 inch if designed for hunting small game,
 - (c) muzzle-loading firearms,

- (d) black powder cartridge firearms,
 - (e) cap and ball revolvers.

No. 8 **Excluded firearms**

Page 6, Schedule 2[9], proposed section 8A. Insert after line 3—

- (4) Air rifles with a calibre of .177 inch that meet Olympic and world championship criteria do not count towards a limitation in this section.

No. 9 **Excluded firearms**

Page 6, Schedule 2[9], proposed section 8A. Insert after line 3—

- (5) Shotguns that meet Olympic and world championship criteria do not count towards a limitation in this section.

No. 10 **Excluded firearms**

Page 6, Schedule 2[9], proposed section 8A. Insert after line 3—

- (6) Straight pull biathlon rifles with a calibre of .22 inch that meet Olympic and world championship criteria do not count towards a limitation in this section.

No. 11 **Online services**

Page 10, Schedule 2[25], lines 6–8. Omit all words on the lines.
