(2B) Subsection (2)(b) does not apply if the applicant asserts the vehicle is not a non-registrable motor vehicle.
- No. 6 **Donation of forfeited vehicles**
Page 5, Schedule 1[5], proposed section 79B(8). Insert after line 27—
(a1) by donating the vehicle, or parts of the motor vehicle, to another person, whether for re-use or recycling or another purpose,

No. 7 **Stay during internal review**

Page 5, Schedule 1[5], proposed section 79B. Insert after line 35—

- (10A) If a person requests an internal review of a decision to reject an application under this section within 14 days of the decision, the motor vehicle is not forfeited to the Crown until after the internal review is completed and the decision is affirmed.

Page 6, Schedule 1[6], proposed section 255A(1), line 14. Omit “28 days.”. Insert instead—
