Future Inquiry Topics

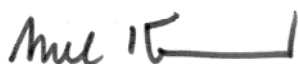
The Committee considered topics for possible future Inquiries:

The Committee considered topics for possible future inquiries:

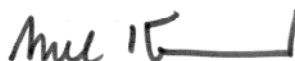
A kids' version of the 9-14 Inquiry Report

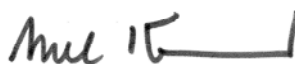
Inquiry into Children and Young People 9-14 years in NSW - Kids Version
